Jacobus Borough Council Meeting Minutes November 2, 2011

Jacobus Borough Council met on the above date at the Borough Municipal Building. Council President Brian Dell called the meeting to order @ 7:00 p.m., and followed with a Prayer and the Pledge of Allegiance. Secretary Cynthia Ferree called roll. In attendance were: Council President Brian Dell, Mayor Greg Gruendler, Council Vice President Bill Eshenour and Council Members: Jeff Hammers, Sandy Sheffer, Judy Gregory and Roger Coleman. Council member Lance Beard and Solicitor Dave Jones were absent. Councilman Lance Beard arrived at approximately 7:24 p.m.

Approval of Council Minutes

Jacobus Borough Council reviewed the minutes from the Council Meeting of October 5, 2011. Councilwoman Judy Gregory made a motion to approve the minutes of the October 5, 2011 Council Meeting as presented and with the following correction: The 'second' to the motion approving the September 7, 2011 Council minutes was made by Councilwoman Judy Gregory, not Roger Coleman. The motion was seconded by Councilman Roger Coleman. Motion carried unanimously.

Approval of Treasurer's Report

Secretary Ferree presented the Treasurer's Report for October 2011. *A motion was made by Councilwoman Sandy Sheffer to approve the October 2011 Treasurer's Report as presented. Councilman Lance Beard seconded the motion. Motion carried unanimously.* The Treasurer's report will be filed for audit.

Persons on Agenda/Public Participation

- A. Patrick Buhl, SEO Mr. Buhl discussed the status of pumps & inspections for existing On-Lot Septic Systems in Jacobus Borough. Few responses have been received. The Borough will review the address list for revision/updates needed for further correspondence to property owners regarding On-Lot Septic requirements according to Borough Ordinance.
- B. Arthur Sinclair, Resident Mr. Sinclair discussed damage to his property (yard & driveway) at 12 Hillside Drive caused by plowing of snow from the October 2011 winter storm. No action will be taken by Jacobus Borough.

Action Taken

- A. Winter Maintenance Contract 1 (One) bid for Jacobus Borough's Winter Maintenance contract was received and opened at approximately 7:18 p.m. A motion was made by Councilman Lance Beard to approve as proposed, L. T. Godfrey as low responsible bidder for Jacobus Borough's 2011-2012 Winter Maintenance contract. Council Vice President Bill Eshenour seconded the motion. Motion carried unanimously.
- B. EIT Ordinance Councilwoman Judy Gregory made a motion to approve EIT Ordinance 2011-3. The motion was seconded by Councilwoman Sandy Sheffer. Motion carried unanimously.
- C. JLS Resignation A motion was made by Council Vice President Bill Eshenour to accept Lori Starz's resignation from her appointment to the JLS Executive Board as a Jacobus Representative. Councilman Roger Coleman seconded the motion. Motion carried unanimously.
- D. JBSA Resignation Councilman Roger Coleman made a motion to accept James E. Morouse's resignation from his appointment to the Jacobus Borough Sewer Authority. The motion was seconded by Council Vice President Bill Eshenour. Motion carried unanimously.
- E. YATB Resignation A motion was made by Councilman Lance Beard to accept Jenna G. Peeler's resignation to her appointment as a Jacobus representative to the York Adams Tax Bureau. Councilwoman Judy Gregory seconded the motion. Motion carried unanimously.
- F. YATB Appointment Councilman Jeff Hammers made a motion to appoint Roger W. Coleman as a Jacobus representative to the York Adams Tax Bureau. The motion was seconded by Councilman Lance Beard. Motion carried unanimously. Roger will continue his appointment as Jacobus' representative to the TCC also.
- G. JBSA Appointment A motion was made by Councilwoman Judy Gregory to appoint John E. Coleman to the Jacobus Borough Sewer Authority to fill a vacated seat expiring Dec. 31, 2011. Council Vice President Bill Eshenour seconded the motion. Motion carried unanimously.
- H. JLS Appointment Councilman Jeff Hammers made a motion to appoint Terri Dillon as a Jacobus representative to the JLS Recreation Association's Executive Board to fill a vacated seat expiring Dec. 31, 2011 and to a new term beginning January 2, 2012 & expiring Dec. 31, 2012. The motion was seconded by Councilman Lance Beard. Motion carried unanimously.
- I. 'No Parking' Ordinance Amendment A motion was made by Councilman Jeff Hammers to authorize Stock and Leader to advertise an amendment to Jacobus Borough's 'No Parking' Ordinance to include No Parking, Stopping or Standing from Meadow Street to 100' North of Meadow Street on the east side of Main Street, due to sight distance upon pulling out onto Main St. Council Vice President Bill Eshenour seconded the motion. Motion carried unanimously. The amendment is due to a traffic study conducted by a traffic engineer through the York County Planning Commission.
- J. Code Adoption Ordinance Councilwoman Sandy Sheffer made a motion to authorize Stock and Leader to advertise the "Notice of Introduction of the Code Book of Ordinances for Jacobus Borough" for adoption at the Dec. 7, 2011 Council meeting. The motion was seconded by Councilwoman Judy Gregory. Motion carried unanimously.
- K. Foreign Fire Insurance A motion was made by Councilman Lance Beard to authorize disbursement in the amount of \$20,490.70, the 2011 Commonwealth allocation received by Jacobus Borough for Foreign Fire Tax Relief, to Goodwill Fire Company's Fire Relief Association. Councilman Roger Coleman seconded the motion. Motion carried unanimously.

- L. Audit Proposal Councilwoman Judy Gregory made a motion to accept a 3 year proposal as presented from SF & Company to perform Jacobus Borough's state required annual audit and filing of the Financial Report. The motion was seconded by Councilwoman Sandy Sheffer. Motion carried unanimously.
- M. 2012 JLS Budget A motion was made by Councilman Roger Coleman to approve the JLS Recreation Association 2012 budget as presented. Jacobus Borough's portion of the JLS budget will be \$3,241.48 in 2012. Councilman Jeff Hammers seconded the motion. Motion carried unanimously.
- N. 2012 GF Proposed Budget/Tax Levy Councilman Roger Coleman made a motion to authorize Secretary Ferree to advertise Jacobus Borough's proposed 2012 General Fund Budget of \$451,076.00 & Tax Levy Ordinance for adoption at the December 7, 2011 Council meeting. The tax levy is proposed to remain at 1.7mil. The motion was seconded by Councilwoman Sandy Sheffer. Motion carried unanimously.
- O. 2012 LF Proposed Budget A motion was made by Councilman Lance Beard to approve the adoption of Jacobus Borough's proposed 2012 Liquid Fuels budget for \$43,383.41. Councilwoman Judy Gregory seconded the motion. Motion carried unanimously.
- P. DVR System Server Rack Councilman Roger Coleman made a motion to approve the purchase of a Server Rack at a cost of \$899.00, including installation and a back-up power supply, as proposed by Crime Intervention Alarm Co., Inc. The motion was seconded by Councilman Jeff Hammers. Motion carried unanimously.
- Q. Comcast Internet Service A motion was made by Council Vice President Bill Eshenour to purchase internet service as proposed by Comcast at a cost of \$34.90 p/month with installation fees waived. Councilman Roger Coleman seconded the motion. Motion carried unanimously.
