## Chapter 243. Yard Sales

[HISTORY: Adopted by the Borough Council of the Borough of Jacobus 7-5-1995 by Ord. No. 120 (Ch. 13, Part 3, of the 1984 Code of Ordinances). Amendments noted where applicable.]

#### **GENERAL REFERENCES**

Peddling and soliciting — See Ch. **160**. Zoning — See Ch. **250**.

### § 243-1. Definitions.

As used in this chapter, the following terms shall have the meanings indicated:

#### **APPLICANT**

The person applying for the permit. An applicant shall be considered to represent his entire household.

#### BOROUGH

Borough of Jacobus, York County, Pennsylvania.

#### GOODS

Any goods, warehouse merchandise or other personal property capable of being the object of a sale regulated hereunder, except for homegrown agricultural products.

#### PERMIT

Permit issued by the Borough to conduct a yard sale.

#### PERSONS

Individuals, partnerships, family groups, voluntary associations and corporations.

#### YARD SALE

The sale or offering for sale of 10 or more new, used or secondhand items of personal property, not including homegrown agricultural farm products, at any one residential premises at any one time; includes all sales in residential areas entitled "garage sale," "yard sale," "tag sale," "porch sale," "lawn sale," "attic sale," "basement sale," "rummage sale," "flea market sale" or any similar casual sale of tangible personal property.

## § 243-2. Frequency and duration; restrictions on conduct; signs.

A. Each household shall be entitled to one permitted yard sale, as identified in § 243-3A, in any twelve-month period. The maximum duration of said sale shall be three consecutive days, between dawn and dusk. No merchandise intended to be sold shall be displayed on the premises prior to the hours of the sale.

- B. No amplified sounds shall be permitted in connection with the sale. No loud or boisterous conduct shall be permitted on any premises, nor will vehicles impede the passage of traffic on any roads or streets in the area of the premises where the sale is being conducted.
- C. In the event of an emergency, all such persons shall obey reasonable orders from any member of the Police Department or the Fire Department in order to maintain the public health, safety and convenience.
- D. Any and all placards, signs or billboards related to any yard sale within the Borough shall be removed within 24 hours of the conclusion of said yard sale.

### § 243-3. Permits.

- A. No yard sale, except as identified in Subsection B below, may be held until a permit therefor has been obtained. The permit cost shall be \$10. All permit fees shall be paid to the Borough prior to issuance of the permit. The permit granted by the Borough shall be prominently displayed on the premises during the sale.
- B. A yard sale shall be allowed in the Borough without a permit on the following days:
  - (1) The Friday, Saturday, Sunday and Monday of the Memorial Day weekend.
  - (2) The first Friday and following Saturday and Sunday of July.
  - (3) The Friday, Saturday, Sunday and Monday of the Labor Day weekend.

## § 243-4. Enforcement.

The Borough hereby authorizes the Borough Zoning Officer to bring charges before the Magisterial District Judge in accordance with the penalties set forth herein.

## § 243-5. Violations and penalties.

#### [Amended 7-3-2013 by Ord, No. 2013-3]

Any person who shall violate the provisions of this chapter shall be subject to a summary criminal proceeding before the Magisterial District Justice as provided by the Pennsylvania Rules of Criminal Procedure, as may be amended from time to time. Upon a finding of a violation, a fine of not less than \$450 nor more than \$1,000, plus costs of prosecution, including court costs and reasonable attorney fees incurred by the Borough to prosecute the violation, shall be imposed, and such person may be subject to imprisonment of up to 15 days in the event such fines and costs are unpaid. Each day that such violation(s) continues shall be a separate violation of this chapter.

# SIGNAGE - REGULATIONS according to Jacobus Borough Ordinance


- No signs may be placed inside the 25' sight triangle at intersections.
- No signs or balloons may be placed on Utility Poles
  (PA State Law ACT 69) or on Municipal Sign Posts
- You must have the property owner's permission when placing a sign on someone else's property.
- All signs must be removed within 24 hours of the completion of the event.

## Additional Guidelines

- Realty Signs May only be placed on the property for sale.

- Banners You must have approval from Jacobus
  Borough Council to place a banner over a cartway.



- § 6905. Nails and other hard substances attached to utility \_\_\_\_\_\_ poles.
- (a) Offense defined. -- A person is guilty of a summary offense if he drives a nail or tack or attaches any metal or hard substance to or into any pole of any public utility pole line.
- (b) Exceptions. -- Subsection (a) of this section does not apply to:
  - (1) the public utility or its licensee using the poles from affixing its metal or other markers or from otherwise using the poles in its public service; or
  - (2) the erecting traffic signs and other signs similar thereto by a municipality when authorized by statute or by the owner of such poles.
